CONSERVATION - OUR WORK ON RARE AND ENDANGERED PLANTS ENCOMPASSED RESEARCH AND STRATEGY, ON-SITE CONSERVATION, AND SEED BANKING. BEGAN WRITING THE UPDATE TO "FLORA CONSERVANDA," IN COLLABORATION WITH THE SIX STATE NATURAL HERITAGE PROGRAMS. THE REPORT USES ANALYSIS OF SHARED FIELD DATA TO ESTABLISH THE TOP PRIORITIES FOR RARE PLANT MONITORING, HABITAT MANAGEMENT, AND SEED BANKING FOR THE NEXT TEN YEARS. THIS YEAR, 290 TRAINED VOLUNTEERS INVESTED 12,000 HOURS IN MONITORING POPULATIONS OF RARE AND ENDANGERED PLANTS IN LOCATIONS ACROSS THE REGION AND IN COLLECTING SEEDS OF 41 SPECIES FOR THE SEED BANK.
