MADE A TOTAL OF 309 SEED COLLECTIONS, COVERING 116 TAXA AT 40 LOCATIONS ALONG THE COAST. THIS IS A GROUND-BREAKING COORDINATED EFFORT ALONG THE EASTERN SEABOARD WITH PARTNERS FROM NEW YORK AND NORTH CAROLINA.

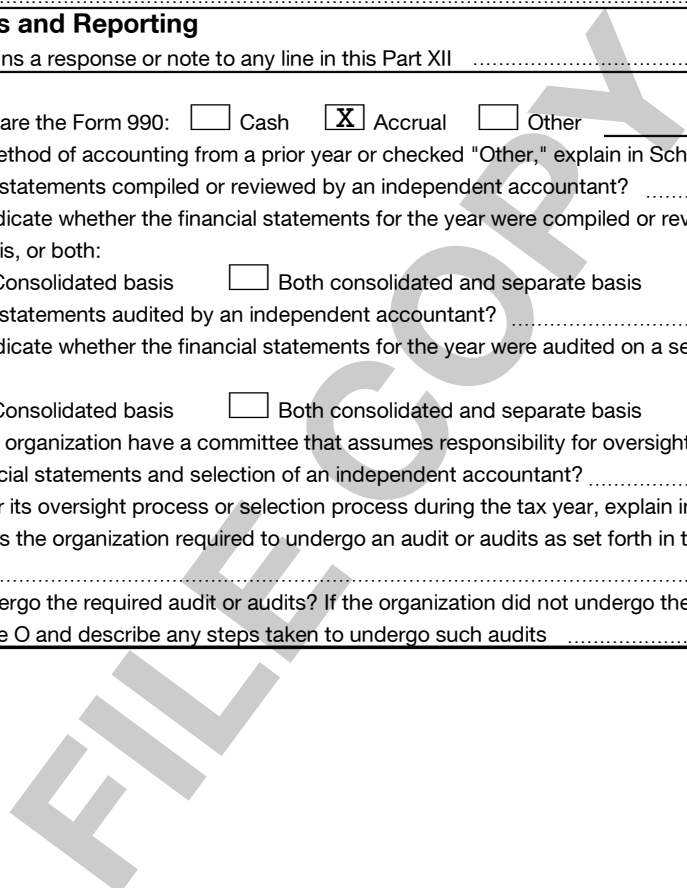

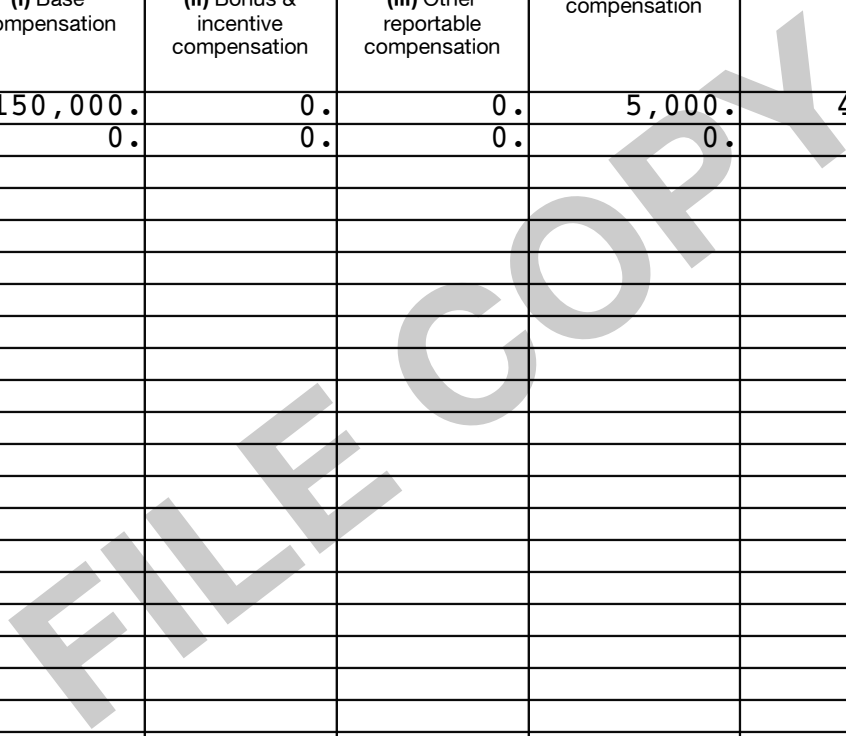
