CONSERVATION - A TWO-YEAR COLLABORATION WITH THE NATURE CONSERVANCY RESULTED IN THE DRAFT OF AND A SYMPOSIUM DEVOTED TO A COMPREHENSIVE ASSESSMENT OF PLANT DIVERSITY IN NEW ENGLAND AND PRIORITIES FOR LAND PROTECTION. THE REPORT, TO BE PUBLISHED IN 2021, PROVIDES A FRAMEWORK FOR PRESERVING PLANT DIVERSITY IN A CHANGING CLIMATE BY IDENTIFYING THE AMOUNT AND LOCATION (AT REGIONAL, STATE, AND PARCEL LEVELS) OF EACH HABITAT TYPE NEEDING PROTECTION TO PRESERVE BIODIVERSITY. THIS YEAR THEY WERE ESPECIALLY PLEASED TO BE ABLE TO ENJOY THE 45-ACRE NATIVE PLANT BOTANIC GARDEN, WHICH AIMS TO EDUCATE AND INSPIRE VISITORS TO USE NATIVE PLANTS IN THEIR GARDENS AND TO CONSERVE THEM IN THE WILD. ALL IN-PERSON PROGRAMS, INCLUDING SCHOOL AND GROUP TOURS, WERE CANCELLED THIS YEAR. WE CONTINUED TO OFFER DISCOUNTED ADMISSION THROUGH PASSES AVAILABLE AT LOCAL LIBRARIES.

AT OUR NASAMI FARM NURSERY, STAFF AND VOLUNTEERS GREW APPROXIMATELY 46,000 NEW ENGLAND NATIVE PLANTS FROM SEED COLLECTED SUSTAINABLY AND ETHICALLY FROM LOCAL WILD POPULATIONS. THESE PLANTS ARE SOLD IN OUR

PUBLIC PROGRAMS - INCREASED EDUCATIONAL ACCESS DURING THE PANDEMIC BY CONVERTING PROGRAMS TO ONLINE FORMATS. 159 PUBLIC PROGRAMS DREW 2,405 PARTICIPANTS ACROSS THE COUNTRY, TO LEARN ABOUT BOTANY, HORTICULTURE, CONSERVATION, LANDSCAPE, AND MORE. AMONG THE MOST POPULAR PROGRAMS WERE THREE NEW ONLINE SELF-PACED CERTIFICATE COURSES, A VIRTUAL SYMPOSIUM ON PLANT DIVERSITY, A RESEARCH TALK ON MANAGING YARDS FOR PLANT BIODIVERSITY, AND A VIRTUAL SERIES FEATURING UNIVERSITY HERBARIA.

WHILE GARDEN IN THE WOODS WAS OPEN AT REDUCED CAPACITY FOR PART OF THE 2020 SEASON, WE WERE UNABLE TO SAFELY PROVIDE VOLUNTEER-LED TOURS AND SCHOOL PROGRAMS. OUR 54 ACTIVE GARDEN PROGRAMS VOLUNTEERS FROM 2019 ARE EAGER TO VOLUNTEER IN 2021.
